21. The qualifications and other conditions prescribed in the present advertisement are subject to the norms stipulated by the University from time to time.
22. The University reserves the right to restrict the candidates to be called for interview/written test/online computer test/typing test to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed as decided by duly constituted selection committee(s) and approved by the competent authority. Call letters for attending interview will be sent only to the short-listed candidates by e-mail.
