Minimum Qualifications and Experience: - **(Faculty of Arts, Sciences, Commerce and Management)**

The terms and conditions with regards to the minimum qualifications and other terms and conditions as the UGC Regulations ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION 2018 and amendments from time to time, shall be followed.

The Minimum Qualifications required for the post of Assistant Professor is as under :-

- i. The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/SET) shall remain the minimum eligibility for appointment of Assistant Professor and equivalent positions wherever provided in these Regulations. Further, SLET/SET shall be valid as the minimum eligibility for direct recruitment to Universities/Colleges/Institutions in the respective state only.

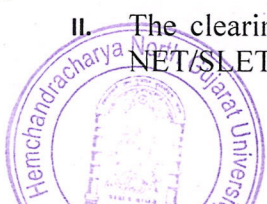
Provided that candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./ Ph.D. Degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or any equivalent position in any University, College or Institution.

Provided further that the award of degree to candidates registered for the M.Phil./Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only.
- b) The Ph.D. thesis has been evaluated by at least two external examiners.
- c) An open Ph.D. viva voce of the candidate has been conducted.
- d) The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a refereed journal.
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in Conferences/ seminars sponsored/funded/supported by the UGC/ ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

- ii. The clearing of NET/SLET/SET shall not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted.



- III. A minimum of 55% marks (without including any grace mark procedure or rounding off) (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.

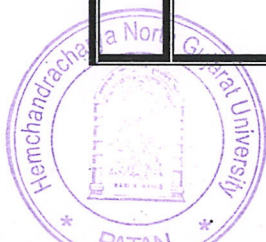
A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe / Other Backward Classes (OBC) (Non - creamy Layer) / Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotors disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

- IV. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19th September, 1991.
- V. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.

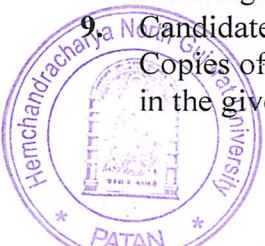

7. Application received after the due date will be liable to be disregarded. The University will not be responsible for postal or any delay. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay due to other unforeseen events or circumstances at any stage. Applications received after the last date and time mentioned above will be rejected.
8. The required qualifications/experience/age shall be considered as on last date of online application submission. The candidates must fulfil all eligibility conditions as of the last date of receiving the application.
9. Candidates applying for the Posts of Assistant Professor shall necessarily submit three (03) Copies of academic score (Appendix II, Table 3A) along with all the supporting documents in the given separate proforma (available on the portal <https://recruitment.ngu.ac.in>)

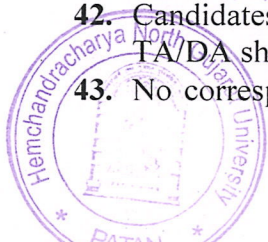


10. Candidates shall enclose all documents of evidence for the Academic score and self-attested copies of certificates towards the evidence of Age, Educational Qualifications, Caste, Physical Disability, Experience, etc. with the application form.
11. The reservations/relaxations policy for SC/ ST/ SEBC/ EWS/ PwD Candidates shall be provided as per the existing Govt. of Gujarat rule and subsequent amendments from time to time till the last date of receiving application.
12. Candidate belonging to SC/ ST/ SEBC/ EWS/ PwD category should submit prescribed certificate as per the Performa of State Government and Norms, failing which the candidate will not be entitled to get the benefit of reserved category.
13. Candidates applying for the reserved posts should clearly state to which category they belong. They must also enclose a valid Certificate issued by Competent Authorities as proof to this effect without which the application will not be considered.
14. Candidates applying for the post(s) reserved for SEBC, should submit a self- attested copy of valid caste certificate specifically mentioning Creamy Layer- exclusion in the format prescribed by Govt. of Gujarat.

17. The present reserved posts for the physical disable candidates will be filled as per the General Administration Department Circular No. CRR-102017-122639-G.2 (Part-1) dated 11/11/2024 and resolution No. CRR-102017-122639-G.2 dated 20/11/2024.
18. Candidates applying for post of Faculty of Arts, Science, Commerce and Management in this advertisement needs to follow the guidelines prescribed by UGC vide Notification dated 18th July 2018 and subsequent amendments from time to time till the last date of receiving application.

44. For Research Papers published, Self-attested proof of peer-reviewed Journal or UGC listed Journals on the date of publication should be provided.
45. Any additional qualifications, experience, number of papers published, honors and other achievements gained by the candidate during the period between the last date of application and the date of conducting the interview shall not be taken into consideration.
46. Candidates, who have obtained degrees or diplomas or certificates for various courses from any Institution declared fake/derecognized by the University Grants Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised.
